BOARDER POLICIES, PROCEDURES AND BOARDER RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT In consideration for my dog being permitted to board at DeWinton Country Kennels for day and/or overnight boarding I make the following representations and agree to all of the following policies, procedures, terms and conditions:

1. PERSONAL PROPERTY. I agree that DeWinton Country Kennels shall not be responsible or liable for any lost, stolen or damaged personal property belonging either to my dog or me. I also understand and agree that my dog's collar may be removed to prevent injury to any dog. If my pet causes any damage to the DeWinton Country Kennels facilities or equipment, I agree to be fully responsible for the full cost of any repair or replacement.
2. BOARDING FEES. I agree to pay for all boarding fees, services and products in the Boarding Application, by cash, debit, mastercard or visa at the time I pick up my Dog after each visit to DeWinton Country Kennels
3. ACCEPTANCES AND ACKNOWLEDGEMENT OF BOARDING PARTICPATION RISK. I fully understand that: (a) there are inherent and potential risks involved with Interactions between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including permanent disability, sickness or death to human or dog; and (b) there may be other risks not known to me nor readily Foreseeable at this time (collectively, "risks"). I fully accept and assume all risks and Responsibility for all risks, including, without limitation, all losses, costs and damages incurred as a result of my or my dog's stay at DeWinton Country Kennels.
4. VETERINARIAN LIABILITIES AND CARE. I agree to allow DeWinton Country Kennels to obtain medical treatment for my dog, if, in DeWinton Country sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my dog may need medical treatment. I Agree That I Am Fully Responsible For The Cost Of Any Such Medical Treatment, And For The Cost Of Any Transportation For The Purposes Of Such Treatment, Provided To My Dog.
5. WAIVERS, RELEASE AND INDEMNIFICATION. I HEREBY EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND AND COVENANT NOT TO USE DeWinton Country Kennels, and their invitees, owners, employees, volunteers, from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, EXPENSES OR DEMANDS (including reasonable attorney's fees) OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releasers, including negligence, and

(ii) my or my dog's participation in activities at DeWinton Country Kennels. I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS "POLICIES, PROCEDURES AND BOARDING RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" (THE "AGREEMENT") AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THAT THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY DOG(S).

I, the undersigned, hereby acknowledge and agree that all the information provided in this Boarding Application is complete and accurate to the best of my knowledge. Waiver of Liability, Assumption of Risk and Indemnification Agreement (the "Agreement"), as they may be amended from time to time, which are attached and fully incorporated into this application. I hereby execute the Agreement for my dog, myself and my heirs, successors, representatives and assigns. I further attest that if I am not the sole owner or representative of the dog subject to this application, that my signature is sufficient to enter into this Agreement for and on behalf of any other owner or representative.
